REMINDERS

If your school district's lunch system provides e~Funds for Schools with student meal balances, chances are parents have Low Meal Balance Notices and/or Auto Replenishment enabled. Before school ends for the summer, we advise Low Meal Balance emails and Low Meal balance payments be disabled to prevent unnecessary auto replenishment payments.

e~Funds for Schools also offers users the ability to set up a recurring pre-authorized payment. This capability allows for a user to set up a recurring payment on a weekly, bi-weekly or monthly frequency. In order to prevent unnecessary pre-authorized payments during the summer months, EFS recommends Pre-Authorized payments be disabled.
